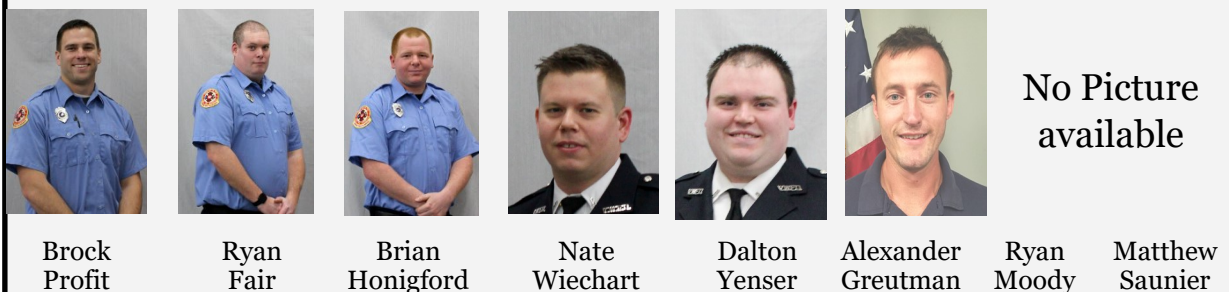

2019 IN REVIEW

2019 was an exciting and busy year for the Van Wert Fire Department. The highlight of the year was celebrating our departments 150 years of service to Van Wert City! On Sept 15, 2019 the department held an open house and the turnout was amazing! It was estimated that over 1000 individuals attended the open house, more than we ever imagined. It was such an incredible opportunity for our personnel to highlight our services for our citizens. We, as a department, thank everyone for attending and supporting your fire department!

The department continues to remain busy with emergency responses. The department set astounding record of 2029 incident responses, 5.6 per day, in 2019. Of those responses 90% are Emergency Medical Responses which totaled 1815. We responded to 33 fire responses with 18 structure fires. The remaining 242 responses were hazardous conditions with no fire, service calls, good intent calls and false alarms.

The department continues to work with the community youth by participating in the school's CEO internship program and starting a departmental fire explorer program. Through the CEO program the department has hired 3 of the fire participants as reserve firefighters on our department. Along with emergency incidents our personnel completed 105 inspection activities, 48 public education/relations events, flowed and tested 566 water hydrants, tested 21,000 feet of fire hose, 34 station tours, 18 classroom presentations. Our personnel completed 4187 hours of training and, 488 hours of building maintenance/remodeling.

The department also began design on a new medic with Braun Ambulance. This unit will replace a 2004 Braun medic and we anticipate delivery in early 2020.

Additionally, the department has hired two new personnel in 2019. Brett Schumm and Ethan Fraker and both have completed their Firefighter 2 and EMTB. On our reserve list we added Dalton Yenser, Ryan Moody, Matt Saunier and Alexander Greutman.



A Message From the Chief

I am honored to submit the 2019 Annual Report for the Van Wert City Fire Department. This document is a snapshot of last years accomplishments and provides an overall view of the all-hazard emergency service organization that serves our great community.

Since 1869, our department mission of providing a professional emergency service for our community, protecting the lives and properties within it, remains our priority. Our highly trained and dedicated force of firefighters take pride in meeting that mission daily, in every possible way.

The Van Wert Fire Department is a full-service fire department that provides all hazard emergency services to over 11,000 residents in a 14 square mile area. This is accomplished with 19 fulltime firefighter/EMTs and 10 reserve firefighters. We are also the only fulltime paid department to provide Advanced Life Support for the entire county, encompassing 410 square miles. Our scope of responsibilities to our community include:

- Fire Suppression
- Emergency Medical Services
- Community Risk Reduction
- Special Rescue (Water, Ice, Confined Space, Grain Bin, High Angle, Haz Mat)
- Emergency Preparedness
- Terrorism/ Mass Killings
- Health/Infectious Disease

As we look forward to 2020, the department will continue to look at the annual increase in run volume, in just 3 years we have seen an increase of 10% over the 3 years. Studies are indicating there will be 20% increase in call volume over the next ten years due to the aging baby boomer generation. Just in the last 10 years, since 2009, we have seen an increase of 45% in run volume in our department. Due to the increased run volume, our department has made operational changes to maximize our efficiencies, but if no changes are made over the next ten years, the Fire Department will not be able to maintain its current levels of service to the City. To prepare for the potential increase in call volume, the Fire Department will continue to look at opportunities to enhance our services and ability to serve the public though technology, research and data. The Fire Department plans on developing and utilizing a strategic plan to meet the community expectations in the years to come.

On a personal note, I want to thank Van Wert City Council, City Administration, each member of our department, our business community, schools, neighboring public safety agencies and the citizens for their outstanding continued support. It is a privilege to serve as your Fire Chief!

The Van Wert Fire Department has a long-standing history of providing quality service and programs to our community. We stand committed to expanding on this tradition in our future endeavors through collaborative community interaction and the enhanced delivery of customer care services. We look forward to a positive and productive 2020.

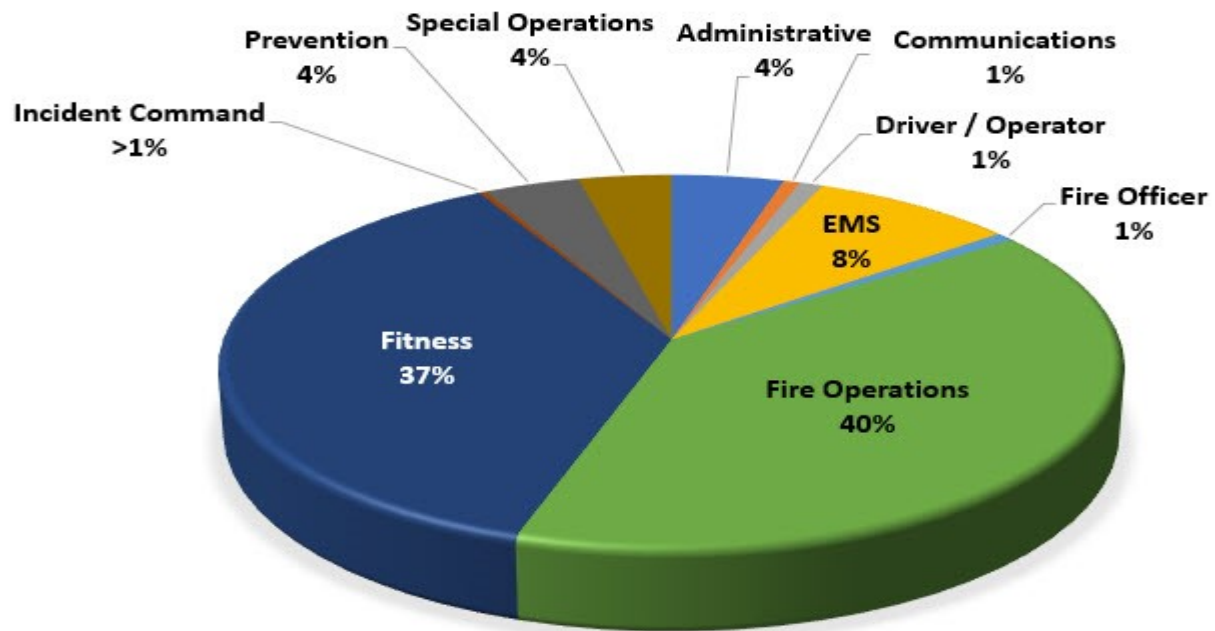
A major goal set this last year was to decrease our out of the station time (turnout time) to under 2 minutes. This was not easily calculated until this year with the department moving to radio dispatching, due to the inability to record to the second, previously. Since the change we have achieved that goal and have an average turnout time of one minute forty-five seconds. This also reflects in the department's average response time to the scene of five minutes and forty-three seconds.



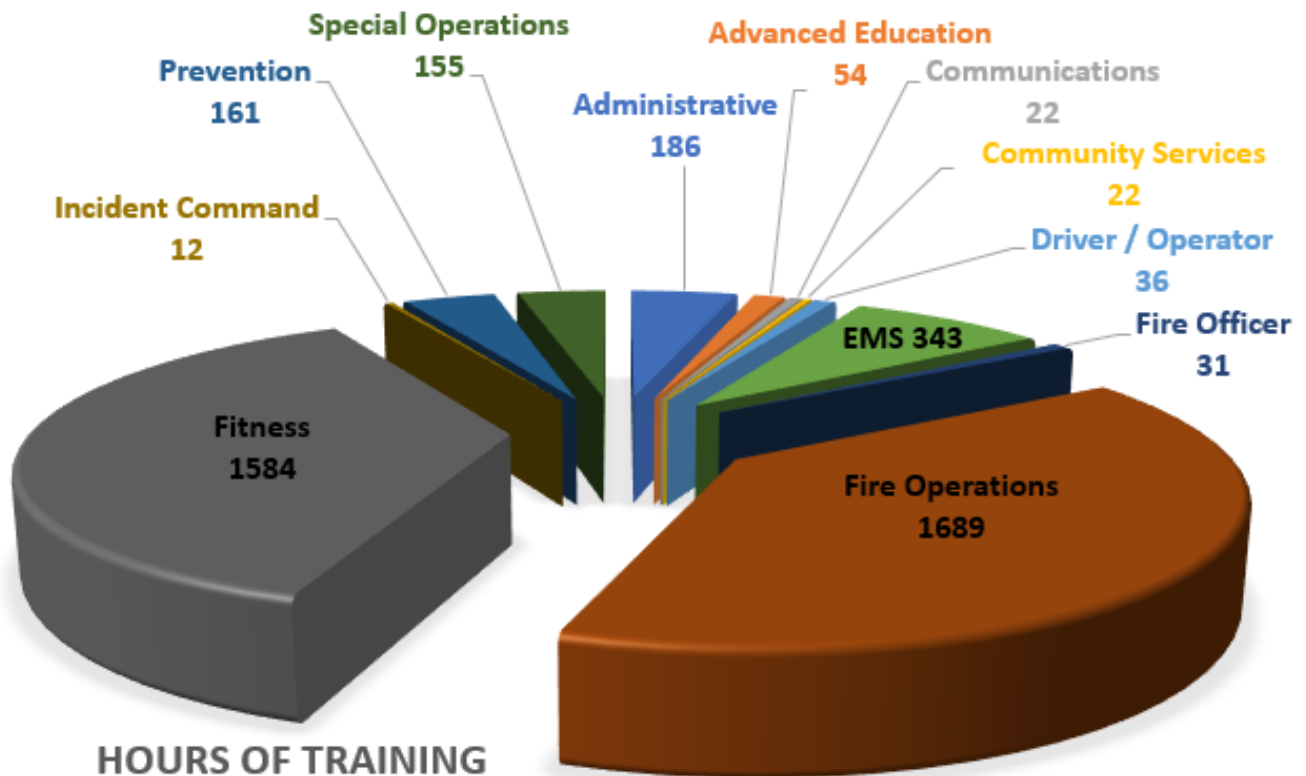

COMMUNITY RISK REDUCTION

In 2020 the department completed 105 inspections of all types. The Van Wert Fire Department provides annual, sprinkler, occupancy certification, fire alarm systems, home, plan review, pressure testing, assembly use and many other fire safety inspections.

The department continues to work on our community risk priorities for the City of Van Wert and our contractual area. This is a priority goal for our fire department in 2020. Community Risk Reduction (CRR) is used to prioritize local risk to allocated the needed resources, and prevention, to reduce the occurrence of emergencies and their impact.

Currently, the fire department accomplish inspections with our lieutenants and fire chief, along with staff personnel, when available.



The department completed its 6th year of the “No Child Sleeps Unprotected” in conjunction with the Van Wert County Fire Fighters Association on providing a 10 year smoke detector to every kindergartener.

EMERGENCY MEDICAL SERVICES

Emergency Medical responses continue to be the majority of the departments emergency responses at 90% of our runs.

EMS responded to 1374 Advanced Life Support and, 45 Basic Life Support incidents. The department also gave mutual aid support on 73 incidents throughout Van Wert County.

We continue to be the primary ALS unit for the entire Van Wert County, encompassing 410 square miles.

The department made 362 responses To incidents that the local private ambulance was unable to cover.

Presently, the department is staffed with 14 EMT Paramedics, 3 EMT advanced, and 7 EMT basic.

The department responded to 380 fall-lift assist in 2019. This is a service That is provided at no extra cost to our citizens.

The department continues to develop it Rescue Task Force team. The department conducted a

joint training at Lincolnview Schools this past summer with the Van Wert County Sheriff. The safety of our schools remains a high priority.

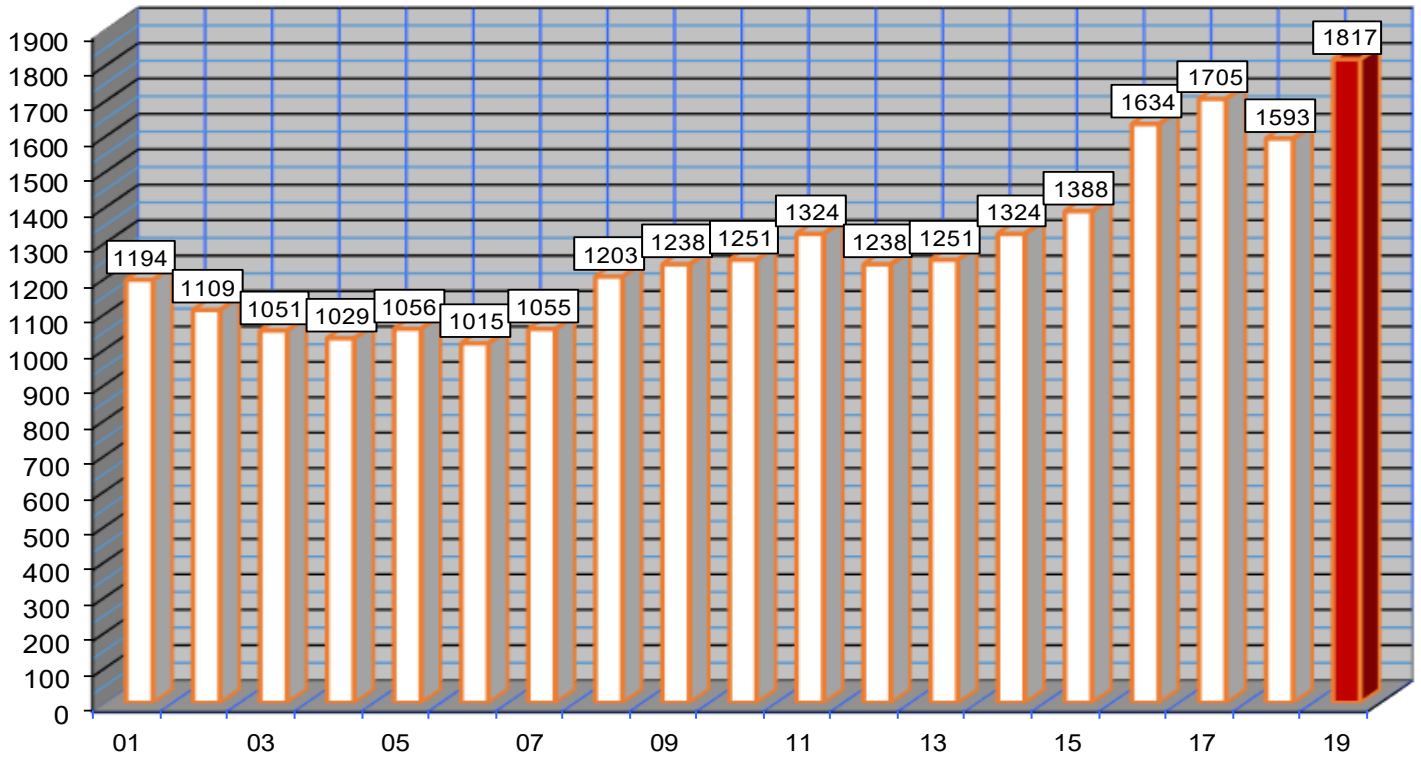

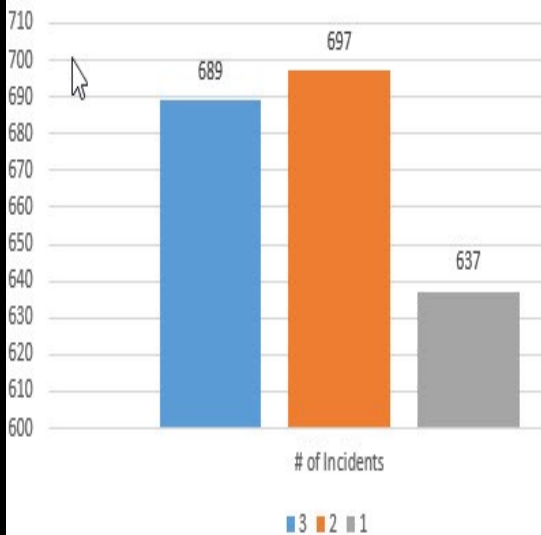

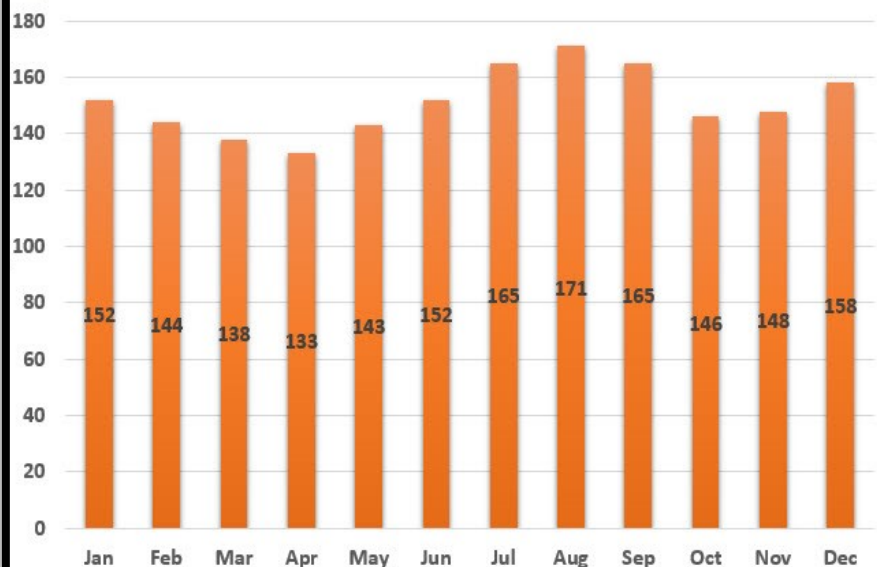
Total EMS Calls Per Year



Incidents by Shift



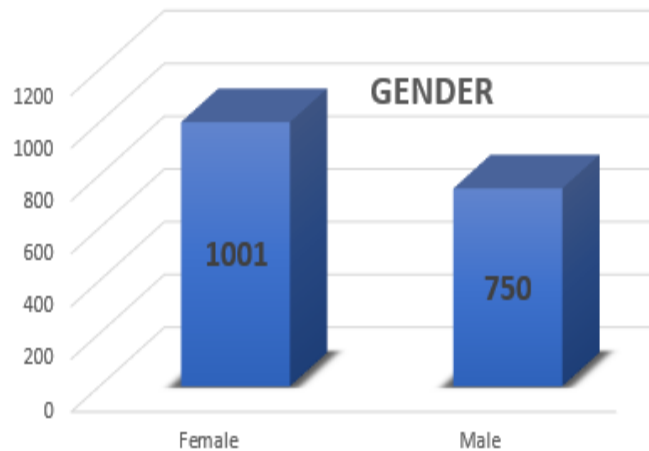
EMS by Month



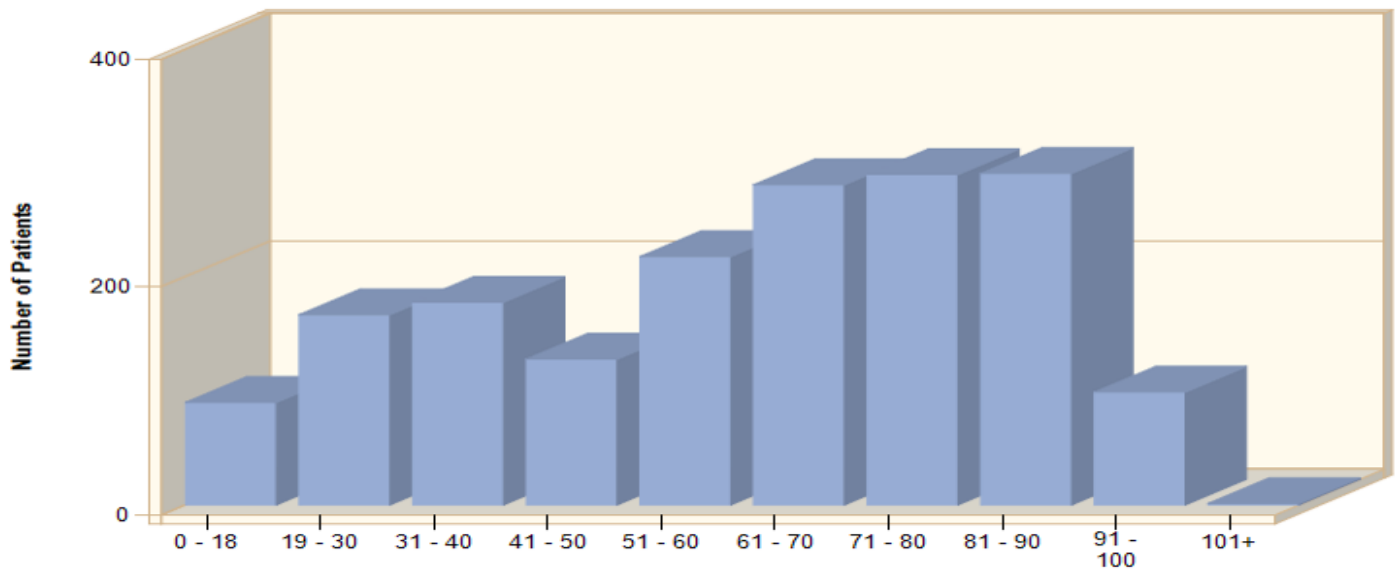

DEPARTMENT GENERAL INFORMATION:



The Van Wert Fire Department is an ISO class 3 rated protection department; whose primary response district is the City of Van Wert and 6 square miles of contracted areas. The total area is approximately 14 square miles and protects a population of 10,969 (2017 US Census). We also respond to provide mutual aid services to all the government based Fire and EMS departments in the county upon their request.

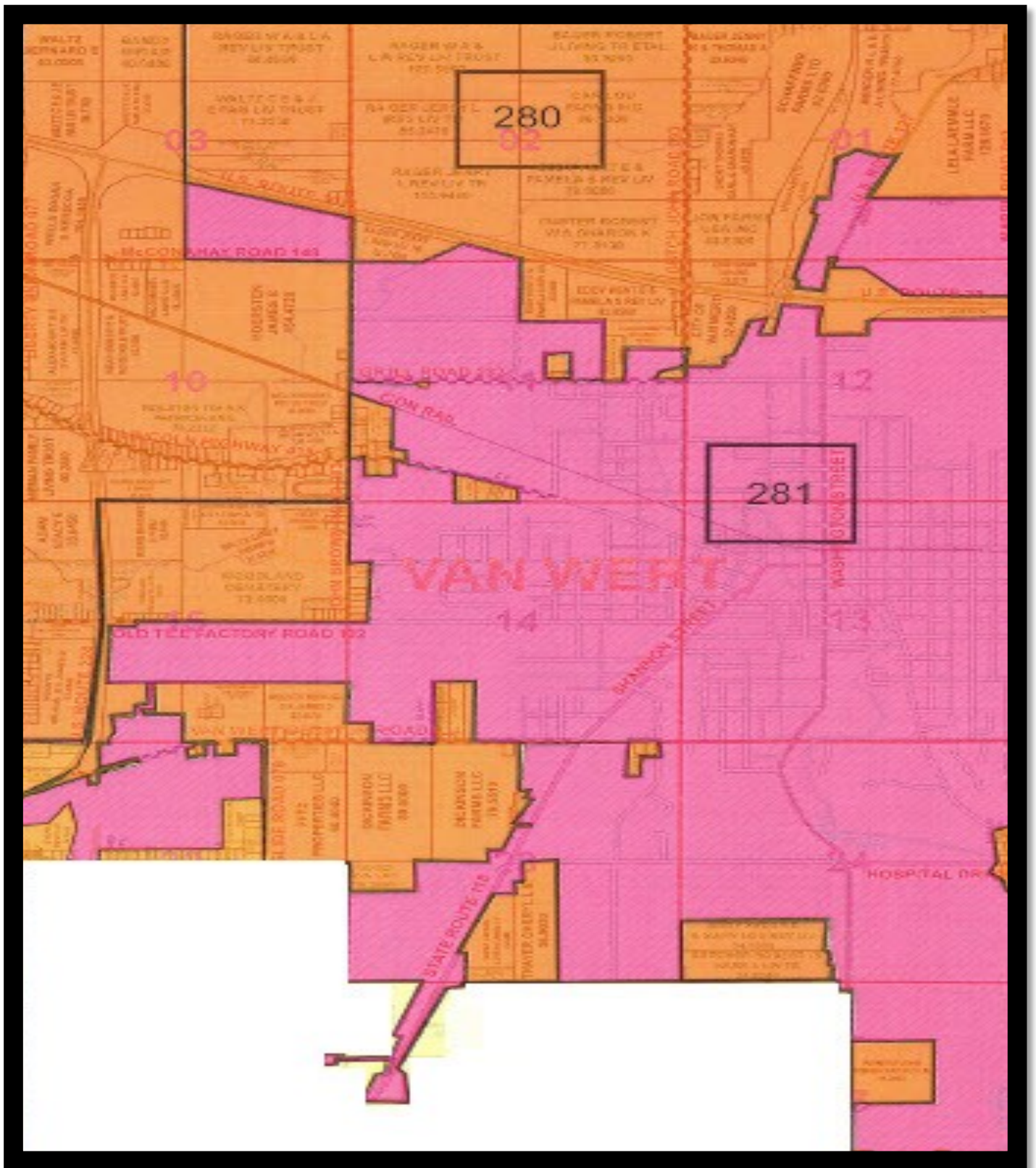
Our firefighters work in a three platoon system, with three shifts of six personnel. Each shift is staffed with one Captain and one Lieutenant. Fire personnel work a 24 hour on duty and 48 hours off duty schedule which is considered to be a 56-hour work week. The full time firefighters are augmented by paid on-call reserve force of ten firefighters. The average combined experience of all our personnel is 11.5 years. The average fire service experience of our officers is 25.0 years.

The Van Wert Fire Departments budget for 2019 was \$2,262,094.99 and includes revenue sources from local taxes, grants, EMS billing, fire protection fees, donations and false alarm billings. Specifically, EMS billing generated \$377,974.89 in 2019. The total budget reflects 90% dedicated to personnel, 10% operational cost from the general fund. The .22 capital fund provided \$305,462.33 for capital purchases including a 2019 Ford/Braun ambulance at a cost of \$243,640.00.

Looking forward to 2020 the fire department has some exciting challenges and goals. One of the most exciting is a collaboration with Vantage Career Center on the joint development of a fire service training grounds and facilities. The development of this training grounds is multi-beneficial for our community. It will provide a training area for Vantage, our department and surrounding fire departments, and provides additional scoring for our department to get closer to becoming an Insurance Service Office (ISO) rated 2 department. The department has purchased a new school car, and has applied for a FEMA Assistance to Firefighter Grant (AFG) for updating the diesel exhaust removal system in the department to meet the NFPA 1500 standard on 100% exhaust capture.

The department goals for 2020 are: Occupancy Vulnerability Assessment Profile (OVAP) score for all occupancies within our response area, 100 fire inspections, complete a preplan on all occupancies, train 1 hour per day minimum, and complete the fire stage of the training grounds.

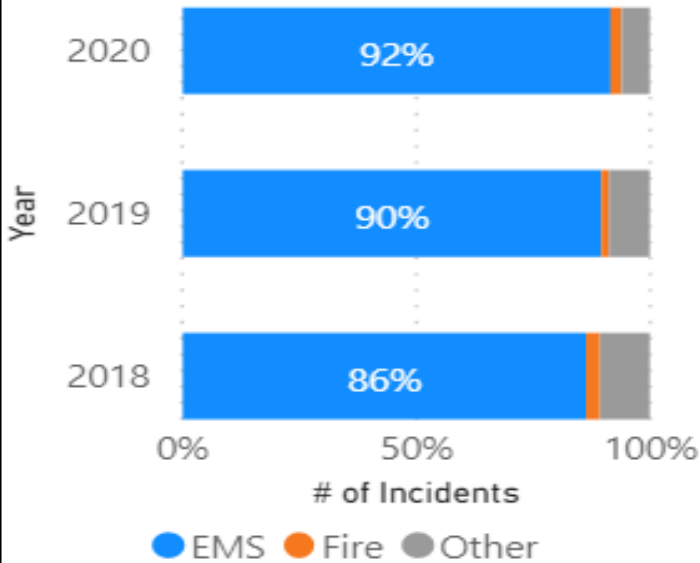

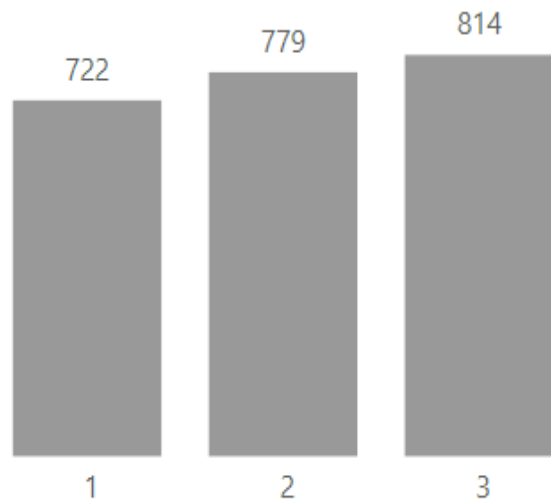

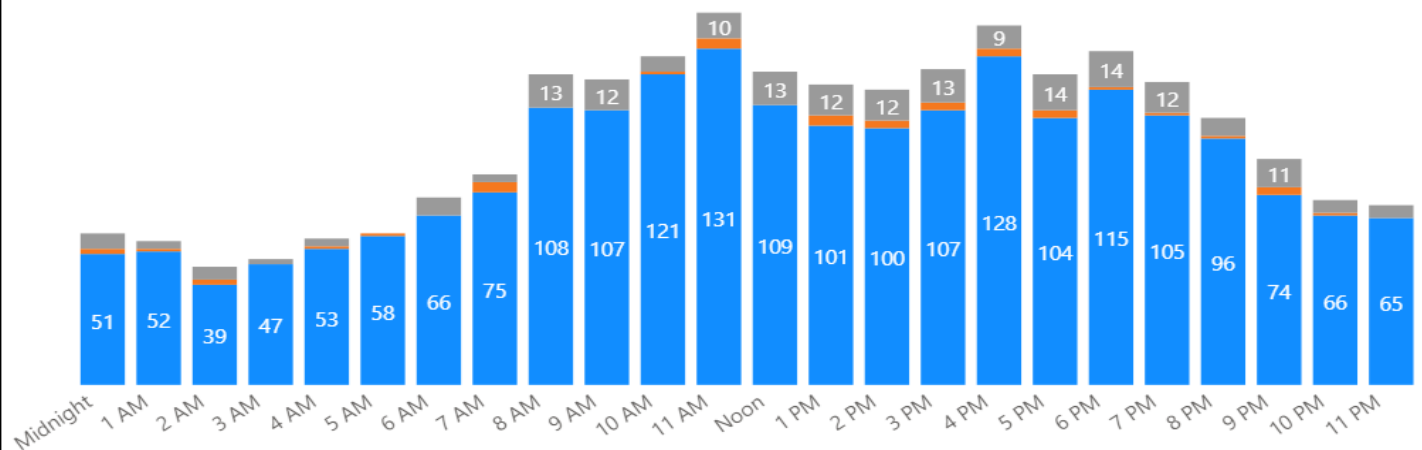

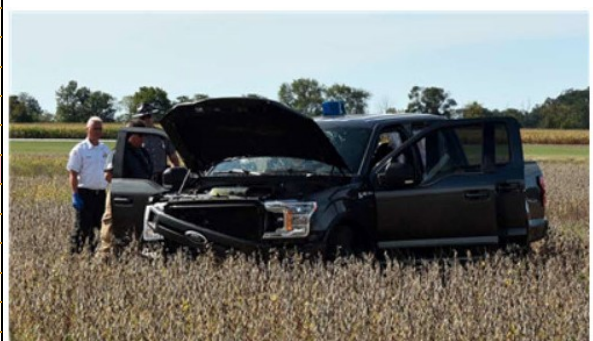
