July 24, 2023

President Jerry Mazur called the meeting to order at 6:33 p.m.

Reverend Frank Howard gave the invocation.

On call of the roll: Marshall, Kallas, Bowers, Agler, Moore and Davis were present.

Bowers made a motion to excuse Stinnett from the meeting. Agler seconded; all concurred.

**AUDITOR:** Martha Balyeat indicated that the city tax budget must be passed at tonight's meeting.

**LAW DIRECTOR:** The Law Director discussed how city council has traditionally set salaries before the filing deadlines for petitions but after research, it is not required by the Ohio Revised Code.

The Law Director indicated that the code violation charges are down significantly compared to 2022.
